## The ENMAX Energy Corporation ("ENMAX ENERGY") Easymax® Switch to Online Bills Summer 2025 Contest

## **OFFICIAL CONTEST RULES**

## THIS CONTEST IS OPEN TO EASYMAX CUSTOMERS ONLY AND IS GOVERNED BY CANADIAN LAW

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. CONTEST PERIOD: The Easymax Switch to Online Bills Summer 2025 Contest (the "Contest") begins at 8:00 a.m. Mountain Time ("MT") on July 3, 2025, and ends at TIME 11:59 p.m. MT on August 31, 2025 (the "Contest Period").
- **2. ODDS OF WINNING:** Odds of winning are dependent on the total number of eligible entries received during the Contest Period in accordance with these Official Contest Rules (the "Official Rules").
- **3. ELIGIBILITY:** The Contest is open to individuals, who, as at the time of entry: (i) are Easymax customers, (ii) are aged 18 years or older, and (iii) comply with these Official Rules. Employees of ENMAX are not eligible to enter the Contest.

All entries are subject to verification at any time. ENMAX ENERGY reserves the right, in its sole and absolute discretion, to require proof of identity and/or eligibility (in a form acceptable to ENMAX ENERGY – including, without limitation, government-issued photo identification) to participate in this Contest. Failure to provide such proof to the satisfaction of ENMAX ENERGY in a timely manner may result in disqualification.

- **4. CONTEST ENTRY:** You will be automatically entered into the Contest when you do one of the following, during the Contest Period:
  - 1) Switch your bill delivery preference from paper bills to email/online bills by managing your preferences at easymax.ca.
  - Enter pursuant to the NO PURCHASE METHOD OF ENTRY: Eligible entrants may obtain one (1) entry without entering as described above, by writing a hand written twenty (20) word unique and original essay describing what you do to conserve energy and mailing this entry via regular mail (in an envelope bearing sufficient postage) along with your first name, last name, telephone number and complete mailing address (including postal code) to ENMAX Energy Corporation, Easymax Switch to Online Bills Summer 2025 Contest, 141 – 50 Avenue S.E., Calgary, Alberta, T2G 4S7. Upon receipt of your mail-in no-purchase entry request in accordance with these Official Rules, you will receive one (1) entry in the Contest. To be eligible, all mail-in no-purchase entry requests must: (i) be received separately in an envelope bearing sufficient postage, and (ii) be post-marked during the Contest Period and received by no later than September 2, 2025. The Releasees (defined below) take no responsibility for any lost, stolen, delayed, illegible, damaged, misdirected, late or destroyed mail-in no purchase necessary entry requests.

All eligible entries received in accordance with these Official Rules will be entered into the random prize draw. There is a limit of one (1) entry per person permitted during the Contest Period. Multiple entries may, in the sole and absolute discretion of ENMAX ENERGY, result in disqualification from the Contest and forfeiture of any prize(s) awarded. More than one entry from the same person may, at the sole and absolute discretion of ENMAX ENERGY, void all entries from that person. ENTRIES WILL NOT BE JUDGED BUT WILL BE DISQUALIFIED IF THEY DO NOT COMPLY WITH THESE OFFICIAL RULES (AS DETERMINED BY ENMAX ENERGY IN ITS SOLE AND ABSOLUTE DISCRETION).

**5. PRIZE AND DRAW DATE:** There are fifty (50) prizes (a "**Prize**") available to be won. The approximate retail value of the prize is **\$100.00 CAD**. Each Prize consists of the following:

One (1) \$100 ENMAX Energy bill credit. The \$100 bill credit will be applied to the Easymax account provided by the winner within 60 days of completion of a prize claim form.

There will be two draw dates. On **August 1, 2025** (the first "**Draw Date**"), at 141 - 50 Avenue S.E., Calgary, Alberta at approximately 10:00 a.m. MST, twenty-five (25) eligible entrants will be selected for a Prize by random draw from among all

eligible entries received in accordance with these Official Rules. Entrants need not be present to be eligible to win. On **September 3, 2025** (the second "**Draw Date**"), at 141-50 Avenue S.E., Calgary, Alberta at approximately 10:00 a.m. MST, twenty-five (25) eligible entrants will be selected for a Prize by random draw from among all eligible entries received in accordance with these Official Rules. Entrants need not be present to be eligible to win.

- **6. NOTIFICATION:** ENMAX ENERGY or its designated representative will make a minimum of three (3) attempts to contact the selected entrants by telephone (using the mobile/home phone number used/provided at the time of entry) within five (5) business days of the Draw Date. If a selected entrant is unable to be contacted within five (5) business days of the Draw Date, then they will be disqualified (and will forfeit all rights to the Prize) and ENMAX ENERGY reserves the right, in its sole and absolute discretion, to randomly select an alternate eligible entrant from among the remaining eligible entries (in which case the foregoing provisions of this section shall apply to such new selected entrant).

For further clarity, by accepting a prize, the winner consents to the use by ENMAX ENERGY and its advertising and promotional agencies of his or her name, municipality, email address, phone number(s) voice, statements, photograph, and/or other likeness, in or for any publicity or advertisement carried out by or on behalf of ENMAX ENERGY in any manner whatsoever, including print, broadcast or the Internet, without further notice or compensation (except where prohibited by law).

- **9. SKILL-TESTING QUESTION:** In order to win a prize, the selected entrant must first correctly answer, without assistance or mechanical or electronic aid, a time-limited mathematical skill-testing question to be administered, at the sole and absolute discretion of ENMAX ENERGY, either by telephone or in person at a mutually convenient, pre-determined time or on the Prize Claim Form.
