INTERIM 2025 REGULATED RATE TARIFF

Residential

1. This rate applies to “rate classification customers” as defined by the *Rate of Last Resort Regulation* (AR 262/2005).
2. This rate applies to all Residential customers which obtain D100 service pursuant to the ENMAX Power Corporation (EPC) Distribution Tariff.
