On behalf of the ENMAX Power Stakeholder Relations team, we are providing an information package about our proposed CENTRAL CALGARY Transmission Line Replacement Project (the Project).

In accordance with regulatory requirements, you may be receiving notification about this Project because you have an interest in land that is located on or directly adjacent to the existing 3.82L underground transmission line (as illustrated in the enclosed map entitled "Overview Map"). Please note, construction activities associated with 3.82L are only proposed to occur in and around ENMAX No. 3 Substation (139 17 Avenue NW) to accommodate the new electrical connection into that substation.

- The Alberta Utilities Commission (AUC) Public Involvement Brochure: outlines the role of the AUC and the approval process.
